Qualified Domestic Relations Order (QDRO) APERS

The Qualified Domestic Relations Order,(QDRO) was authorized by Act 1143 of 1993 for the Arkansas Public Employees Retirement System (APERS). Who is defined as an alternate payee? For purposes of the APERS QDRO provisions, an alternate payee cannot be anyone other than a spouse, former spouse, child, or other dependent of a participant. This means a vested member's benefit is subject to a QDRO in case of a divorce.

I'm getting divorced: What is a qualified domestic ...

A qualified domestic relations order is a special court order that grants a person a right to a portion of the retirement benefits his or her former spouse has earned through participation in an employer sponsored retirement plan. QDROs are typically prepared during divorce proceedings, though they can be filed years after divorce.
